

1. Masters' degree in Agril. Chemicals/ Agril. Chemistry/ Organic Chemistry/ Analytical Chemistry/ Environmental Science/ Agril. Biochemistry/ Biochemistry with UGC/CSIR/ICAR-NET or GATE qualification
2. The candidate must has Master's Degree with at least 60 % marks OR, equivalent overall grade point average in the above subject with 03 years/ 04 years/ 05 years of Bachelor's degree.
3. A relaxation of 5 % may be provided (from 60% to 55% of marks) at Master's degree level for candidates under SC/ST category.
